SCIENTIFIC PUBLISHING PRACTICES AND OPEN SCIENCE

The volume 9, n.1 of AtoZ scientific magazine represents the moment of transition for the editorial team responsible for its publishing. It is the first issue fully edited by this new team that focuses on aligning the journal with open science practices. After all, we are experiencing a new paradigm of scientific research, aimed at increasing the transparency and openness of the entire scientific production process.

Since its creation, AtoZ has aligned itself with the best scientific publishing practices. This can be seen, for example, by the acceptance of articles deposited on preprint servers, which represents an effort to accelerate the sharing of scientific discoveries. In addition, publication in open access and the use of a Creative Commons license are two other important characteristics for a journal that seeks insertion in an open science context.

Thus, we announce the publication in continuous flow from v.9, n.1 on. Through this new form of publication, we intend to speed up research communication and make the process more dynamic. In this context, authors, readers, reviewers and the editorial team are benefited.
